 - 1. <u>Treasurer's Report</u>: Rachel Fausch presented the Treasurer's report for May for review. General Fund balance from the report was \$63,832.41 with an additional \$11,600.23 in the Capital Fund for a total General Fund Balance of 75,432.64. The Checking Account balance was \$97,061.94 and the Savings Balance of \$168,384.62.

General Fund balance from the report was \$ 64,982.22 with an additional \$17,158.23 in the Capital Fund. The Checking Account balance was \$82,140.45 and the Savings Balance of \$167,804.62.

Also, Craig suggested that paint would be needed. The Property Committee will check into volunteer painting and the issues of lead paint. Christian Donovan will contact Jerry Wicklund to assess the Parsonage and discuss the amount of acreage to be included. An estimate of value will be needed before the forums.
